#### PROGRAM REPORTS

### 1. a) Development Review

Andrew Bicknell, Regulations Coordinator prepared and presented the Development Review report pursuant to *Ontario Regulation 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses*. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for four *Applications for Permission* and one *Minor Works Permit*.

## 1. b) Violation/Appeals Update

The violation currently being addressed by staff is ongoing. The second raft of the engineer's report has been received and hopefully can be resolved in the near future.

2. Amendments to O.Reg. 147/06 - ABCA regulation of development, interference with wetlands and watercourses and alterations to shorelines and watercourses

Geoff Cade, Supervisor of Water & Planning gave background on the amendments. The provincial government and Ministry of Natural Resources have approved actions that have impacted the Conservation Authorities Act and related regulations, policy and operations of conservation authorities. The intent is to simplify and streamline the permitting process under S.28 of the Conservation Authorities Act. The amendments are seen to have limited impact to the ABCA's regulatory program.

Reg 147/06, and

THAT the said 'amending' regulation be submitted to the Ministry of Natural Resources for consideration by the Minister of Natural Resources for the Minister's approval."

3. Conservation Ontario Whitepaper: Watershed Management Futures for Ontario On behalf of Ontario's 36 conservation authorities, Conservation Ontario has provided its whitepaper entitled *Watershed Management Futures for Ontario* to the Ministries of Natural Resources, Environment, and Agriculture Food and Rural Affairs as well as all provincial political parties. The intent is to stimulate a discussion between conservation authorities and the province on options for a renewed watershed management partnership. Five specific areas that should be discussed are: confirmation of a conservation authority mandate; enhancements of conservation authority-provincial ministry relationships; revamped conservation authority governance model; development of a sustainable funding model; improved accountability framework.

#### 4. Conservation Authorities Act - Section 29

Kate Monk, Stewardship and Conservation Lands Supervisor gave an update on activities happening on ABCA conservation lands. A summary of hunting passes sold for permission to hunt on ABCA lands, indicates there are 404 active passes generating \$9000 in revenue. Staff have been blocking off access points where off-road vehicles have been entering conservation lands. A special use permit has been granted for a snowmobile trail in the McGregor Tract on a new logging trail.

#### 5. ABCA Land Securement Plan

Kate Monk gave a presentation outlining the land securement plan developed by the ABCA and approved by the Minister of Natural Resources for the period 2008-2020. The ABCA can protect environmentally sensitive and significant lands by holding title (fee simple) or holding rights on the lands (easements, covenants, lease agreements). Criteria for priority areas would be natural

heritage systems, lands that are suitable for restoration where forest and wetland areas can be increased. The secondary priority would be other ecological or strategic areas such as groundwater recharge or discharge areas and regional flood plain. The properties owned historically by the ABCA have master or management plans that identify adjacent properties that would be suitable for acquisition. A list of target areas was identified through analysis of natural heritage features. These areas represent lands that need to be secured to maintain current levels of forest cover in ABCA watersheds.

## Discussion on Draft Watershed Report Card

Mari Veliz, Healthy Watersheds Coordinator asked the directors for feed back on the draft Watershed Report Cards that will be launched to the public in March. The report cards are to demonstrate the basic question whether the watershed provides water that is drinkable and for recreation. Also how healthy is the water as there are 155 possible physical and chemical attributes for protection of aquatic life. Through accumulated local data, the watershed indicators of forest conditions, surface water quality, wetland cover and groundwater quality are ranked and graded. The directors were asked to provide input to the clarity of the report cards and to identify some top actions needed to enhance the watershed where they live. The comments will be compiled in the next revision.

## **Conservation Education Report**

Julie Stellingwerff, Conservation Education Specialist provided an update on the environmental programs offered during 2012. There were 8000 students participate in school programs and special events. The Weston Environmental Leaders of Tomorrow Program had a successful first year at Camp Sylvan with 7 urban schools participating. The number of bookings for highschool programs increased while elementary aged field trips were less. The summer day camp participation was more successful this year with lots of community interest.

#### **PRESENTATION**

Anne McBride, Conservation Education Assistant gave an overview of the Weston Environmental Leaders of Tomorrow Program. This is a new initiative for the ABCA, and the program is a partnership with the Toronto Region Conservation Authority, the Living City Foundation and funded by the W. Garfield Weston Foundation. The funding targets nature deficit disorder by inviting Grade 6 students from urban schools to a 2 ½ day outdoor experience at Camp Sylvan. There are three phases to the program. The first phase is a pre-visit with the class to prepare them for their Camp Sylvan experience. Second phase is attending the camp and the third phase is a post visit to the classroom. The target areas are Sarnia, St. Catharines, Chatham and London. Some of the students attending are from areas that have a lack of outdoor opportunities which can lead to behavioural challenges. Activities the students are highlights are: loading a dishwasher, hands-on learning, chores, eating three meals a day, taking part in a healthy routine, exercise instead of screen time. A media clip produced as a thank you by one of the schools was shown.
