PROGRAM REPORTS

1. a) Development Review

Andrew Bicknell, Regulations Coordinator prepared and presented the Development Review report pursuant to *Ontario Regulation 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses*. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for five *Applications for Permission* and eight *Minor Works Permit*.

1. b) Violation/Appeals Update

2. Section 29 Conservation Authorities Act

Kate Monk, Stewardship & Conservation Lands Supervisor provided an update on activities at ABCA properties related to Section 29 of the *Conservation Authorities Act*. Patrol officers have laid a trespass charge for a dog off leash at Morrison Dam Conservation Area. There were no incidents reported during the spring wild turkey hunt. A significant encroachment situation has occurred in the Clinton East Conservation Area involving mowing trails, pruning trees, motorized vehicles, recreational trailer, tree stands, alteration to a watercourse and installing a large wooden ramp, building jumps using fill and removing topsoil to create a dirt bike course. The adjacent property owner has been issued orders for removal of property and restoration of the area. An MNR Conservation Officer and Species at Risk biologist are also involved in the investigation and restoration with the respect to the destruction of Species at Risk habitat.

Several Special Use Permits are in effect for research on ABCA properties. The studies encompass terrestrial surveys; maple tree and soil surveys looking at the impact of climate change on ecosystems; and emerald ash borer monitoring in North Middlesex as well as the release of a parasitoid in the Hay Swamp Management Area.

Page 3 June 20, 2013

Staff received a request for permission to establish and use a trail for mountain biking at Clinton East Conservation Area. It is recommended to continue the current uses which allows only pedestrian access on these trails.

3. Invasive Species Strategy

Kate Monk provided the background and Executive Summary for the *ABCA Invasive Species Strategy*. The goals of the strategy are to help prevent new invasive species from entering the ABCA watershed and eliminate or reduce the spread of already present invasive species. Strategy components are prevention, management, monitoring, outreach and education.

4. Funding Request to Provincial and Federal Governments

Mari Veliz, Healthy Watersheds Supervisor reported that the Healthy Lake Huron partnership was formed to address water quality issues along Lake Huron's southeast shore. The collaborative effort is led by the provincial Ministries of Environment, Agriculture and Food, Municipal Affairs and Housing, federal Department of Fisheries and Oceans and Environment Canada. Local representation includes County, Conservation Authority and Health Unit staff. Action plans for implementing best management practices in five priority watersheds have been created. A funding proposal has been developed for requesting provincial and federal financial support. The collaborative is looking for endorsement from agencies and stakeholders along the southeast shore of Lake Huron.

FURTHER, THAT we would like to invite the Province of Ontario and Environment Canada to support this collaborative rural economic development effort and contribute to a sustainable future for our communities, and

FURTHER, THAT we respectively request the Province of Ontario and Environment Canada to contribute \$3.76 million a year for five years, for a total of \$18.8 million dollars, to implement best management practices in the five priority sub-watersheds along the south east shore of Lake Huron."

5. Policy for Drain or Watercourse Enclosures

Davin Heinbuck, Lands & Water Technologist reported that there has been an increase in the number of proposals and actual enclosures (or tile in) of both natural watercourses and municipal drains. The primary reason for the enclosures are improving farming efficiencies in the agriculture sector. The negative and cumulative effect of enclosures of watercourses and drains is emerging as a significant concern in environmental impacts on a subwatershed. The current ABCA policy does not require a permit but provides an advisory role under the *Drainage Act* process. However, Ontario Regulation 147/06 gives ABCA the right to require a permit for enclosures of open drains and natural watercourses since it involves alterations to a watercourse. In response to the question on associated fees, Tom Prout responded that the current ABCA fee schedule addresses the permitting process.

FURTHER, THAT all applicable requirements of Ontario Regulation 147/06 apply to the application."

6. Ontario Community Environmental Fund

Ian Jean, Forestry & Land Stewardship Specialist advised that the ABCA was successful in submitting an application to the Ministry of Environment's Ontario Community Environmental Fund for funding to support environmental education, community outreach and on-the-ground projects such as tree planting and wetlands restoration.

7. Accessibility Project Summary

Brian Horner, Financial Services Supervisor prepared a financial summary of the Accessibility Barrier Free Washroom and Door renovation project. Tom Prout presented the report noting that the project came in under budget.

8. Spring Tree Planting Program

Ian Jean, Forestry & Land Stewardship Specialist presented a summary of the 2013 spring tree planting program. There were 55,400 trees planted which is comparable to other years. ABCA staff planted trees for 34 landowners and organized projects at Dublin Lions Park and in Clinton with students from five Clinton schools. 133 watershed landowners picked up and planted their own tree orders. Funding assistance was received through Habitat Stewardship Program, Huron Clean Water, Ausable River COA, Middlesex Clean Water or Trees Ontario. Trees Ontario is now the largest provider of funds in the watershed.

PRESENTATION

Kevin Worthington, Web/Database Programmer gave a demonstration on upgrades he is completing to the ABCA internal geoportal mapping system. The project will integrate the ABCA's various databases together to increase efficiencies for staff. This project was possible through funding received from the federal Career Focus employment program. There may be opportunity in the future to share some elements of the mapping information through agreements with the member municipalities.
