1. Development Review

The Development Review report pursuant to Ontario Regulation 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses, was prepared by Andrew Bicknell, Regulations Coordinator. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for four *Applications for Permission* and three *Minor Works* applications.

Geoff Cade, Supervisor of Water & Planning, presented an update on four violations pursuant to Ontario Regulation 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses. Staff have been working with the landowners and/or contractors towards a suitable solution. Three of the violators are now going through the application process, however, discussions have terminated with the fourth violator. Staff are recommending that the ABCA proceed with laying charges against the offender who excavated a portion of a natural sand dune within the regulation limit at Part Lot 34, Concession LRW, Municipality of Lambton Shores, without permission of either the landowner or the ABCA.
