PROGRAM REPORTS

1. (a) Development Review

Andrew Bicknell, Regulations Coordinator prepared the Development Review report pursuant to Ontario Regulation 147/06 *Development, Interference with Wetlands and Alterations to Shorelines and Watercourses*. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for ten *Applications for Permission* and nine *Minor Works* application.

1. (b) Violation/Appeals Information Update

Geoff Cade, Supervisor of Water & Planning reported that following a court appearance, staff have entered into discussions with the landowner for restoration of the lake bank discussed at a previous meeting.

2. Existing Development within a Valley Wall

Geoff Cade requested that the Board of Directors consider amending the Authority's Policy and Procedures Manual to permit increased development below the top of a valley bank where the valley bank is flatter than 3:1. Under Ontario Regulation 147/06, the ABCA regulates development below the top of valley banks. Development is generally directed away from these sites due to erosion or soils instability hazards. Currently the Policy & Procedures Manual permits reconstruction or minor additions in cases where slope stability and natural heritage concerns have been addressed. However, increased development in these areas is considered low risk where valley banks are flatter than the standard 3:1.

4. 1st Quarter Financial Statement

Bev Brown, Financial Services Coordinator presented for review the consolidated financial statement to March 31, 2010.

5. Accessibility Customer Services Standard

Tom Prout provided an overview of the *Accessibility for Ontarians with Disabilities Act, 2005* and development of Accessibility Standards for Customer Service. The Authority is a non-profit organization with more than 20 employees and has until January 2012 to comply with the standards. Policy, practices and procedures will be developed and brought to a future meeting for the Board's review.

PRESENTATION

Kari Jean, Aquatic Biologist presented an information session on natural fish kills. In early spring the ABCA received numerous reports about dead fish along the 14 kilometre stretch of the Old Ausable Channel between Grand Bend and Port Franks. The last time there was a fish kill of this severity was seven years ago. It was determined that the cause of the fish die off was natural due to low oxygen. There were many different species affected. Natural fish kills are caused by events beyond anyone's control such as weather. Non-natural fish kills can be due to water quality, pollution inputs or fish diseases. Spring fish kills of carp are quite common in the Parkhill Reservoir as there is an overpopulation of this species so they are already stressed.

Because the ABCA is the local agency with expertise, staff are called on to respond and investigate fish kill cases. The ABCA protocol is to contact Ministry of Environment to report surface water quality issues, the Ministry of Natural Resources with details of the fish die-off and the Department of Fisheries and Oceans regarding any fish habitat disruption.
