#### PROGRAM REPORTS

#### 1. (a) Development Review

Andrew Bicknell, Regulations Coordinator prepared the Development Review report pursuant to Ontario Regulation 147/06 *Development, Interference with Wetlands and Alterations to Shorelines and Watercourses.* Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for five *Applications for Permission* and five *Minor Works* application.

1. (b) Violations Update

Andrew Bicknell provided an update for the directors on recent violations under Ontario Regulation 147/06. In the Port Franks Armstrong West Subdivision a permit was issued, however during the construction there was disturbance to the sand dune system. An engineer's report advised to immediately install a snow fence and have sand move into the hole. Staff are working with the landowner for restoration of the dune.

A new violation has been brought to staff's attention recently on a farm lot located at Pavilion Road and Highway 21. A significant amount of fill was placed in a drainage area. A residence may be put at risk for flooding and there is potential for water quality issues downstream.

The purpose is to establish a base-line from which a new Board is monitored for efficiency. This fall is a municipal election and there may be changes to municipal representatives on the ABCA Board of Directors. The estimate for undertaking a survey, report and presentation is \$2000.

Brian Horner presented the statement of Profit and Loss for the first six months of the year with comparison to the 2010 budget.

# 6. ABCA Forestry Operations Update

Ian Jean, Forestry & Land Stewardship Specialist provided an update on the forestry operations on ABCA lands this year. Thinning of the conifer plantations by Ontario Thinning Specialists is scheduled for later in July and throughout August at a still to be negotiated price. A number of natural hardwood stands are being inventoried and assessed for the need for improvement harvests. One 40 acre section of Parkhill Conservation Area north of McGuffin Hills Drive was marked in March. Three bids were received for undertaking the harvest and the tender was awarded to Arbor North.

# Parkhill Dm Actuator Service

Alec Scott, Water & Planning Manager explained that the two steel seven foot by seven foot gates on Parkhill Dam are raised and lowered by large electric motors and gear boxes (Limitorque actuators). The Limitorque units have been in operation with no major servicing since being installed in 1968. This project was part of the 2010 budget and should provide an additional 30 to 40 years of maintenance-free service on the operation of Parkhill Dam. The Limitorque equipment involved can only be serviced by Flowserve Corporation.

## PRESENTATION

Brynn Upsdell, Resource Technician gave a presentation on the ABCA water quality monitoring program. On a global scale, water quality issues are high nutrients and low oxygen; an overabundance of algae and aquatic plants and widespread sources of pollution. The ABCA Conservation Strategy (1993) identified water quality as the # 1 issue. The three big pollutants are dirt, bacteria and nutrients. The core ABCA water quality monitoring program has 20 sampling sites. In addition, there are 42 other sampling sites undertaken through community programs for a total of 62 sites throughout the watersheds. Two-thirds of the sites are focussed along the lakeshore and gullies. Data is collected on suspended solids, phosphorus, nitrate, and *Escherichia coli*. This information is important to summarize and communicate results to the community. The water quality information is used as a tool for identifying watershed problems and improvement projects. Funding for the ABCA water quality monitoring program mostly comes through partnerships and outside of the ABCA levy.
