Chair Tam asked Burkhard Metzger to speak to his motion. Mr. Metzger indicated he would be making a few amendments to the wording of the original motion. George Irvin asked for a recorded vote on the amendment.

FURTHER, THAT the Board of Directors continues to endorse the use of policies as contained in the 2000 Shoreline Management Plan and the Board of Directors directs staff to provide options to re-engage the public to update the 2000 Shoreline Management Plan."
