PROGRAM REPORTS

1. a) Development Review

Andrew Bicknell, Regulations Coordinator prepared and presented the Development Review report pursuant to *Ontario Regulation 147/06 Development, Interference with Wetlands and Alterations to Shorelines and Watercourses*. Through the application process, proposed developments within regulated areas are protected from flooding and erosion hazards. Staff granted permission for two *Applications for Permission* and two *Minor Works Permit*.

1. b) Violation/Appeals Update

Geoff Cade, Supervisor of Water and Planning reported that staff are in discussion with affected landowners in the Township of Lucan Biddulph to seek a resolution to a violation.

2. Canadian Forest Service Emerald Ash Borer Biological Control Study

Ian Jean, Forestry and Land Stewardship Specialist reported that Ausable Bayfield Conservation Authority has been contacted by the Canadian Forest Service (CFS) as part of their search for candidate sites for a Canadian Emerald Ash Borer (EAB) Biological Control Study. EAB has been present in the Ausable and Bayfield watersheds since 2008, and some areas are now showing heavy ash mortality. The Canadian Forest Service will be establishing a Biological Control Study Release using the American-reared candidate parasitoids and established protocols. It is likely that one or more ABCA-owned properties will be suitable for the study. CFS will be field evaluating potential study sites in late April or May.

3. Phragmites Control Progress

Kate Monk, Stewardship and Conservation Lands Supervisor reported on the progress of the control of *Phragmites australis* (common reed) in Lambton Shores. There is a significant amount of phragmites on Ausable Bayfield Conservation Authority land in Lambton Shores. On-the-ground phragmites control has begun again this year in the Port Franks area with rolling and then burning on ABCA, municipal and private land. Funding for this work is from the Ministry of the Environment Great Lakes Guardian Community Fund. The next step is to monitor phragmites, turtles, and the regrowth of native plants.

4. Quarterly Financial Statement

For the Board's information, Brian Horner, Financial Services Supervisor provided the statement of profit and loss to March 31, 2013.

5. Drainage Act and Regulations Team (DART)

Davin Heinbuck, Lands and Water Technologist provided an update. The DART committee was formed in 2008 due to issues that have arisen in the application of the *Conservation Authorities Act* Section 28 regulations to some activities undertaken under the *Drainage Act*. The DART has been established to deal with these issues and promote good working relationships while meeting *Drainage Act* and *Conservation Authorities Act* legislative requirements. Phase 1 of the DART Protocol is complete and available for use by Municipal Drainage Superintendents and Conservation Authorities. The *Drainage Act and Conservation Authorities Act Protocol: Protocol for Municipalities and Conservation Authorities in Drain Maintenance and Repair Activities* document has received approval from the Ministry of Natural Resources and the Ministry of Agriculture and Food.

PRESENTATION

Mari Veliz, Healthy Watersheds Supervisor made a presentation on the Highlights of the 2013 Watershed Report Card; how compiling watershed data can improve the local environment. Measuring helps better understand our watershed; we can then focus our work where it is needed

and track progress. Watershed environmental indicators include Terrestrial conditions and Aquatic conditions. Conservation Ontario Standards were used to establish the grades. Terrestrial conditions include forest cover, forest interior, streamside cover, and wetland cover. Groundwater quality and surface water quality is summarized in the report.

General actions for improved local watersheds include increasing forest plantings around local woodlots and in non-productive land; enhance wetlands in strategic areas; groundwater testing and investigate wells; surface water drain maintenance practices and land erosion control, manure management, upgrade septics and WWTP where necessary. For specific actions, look at the maps as to where you live, evaluate your property and follow recommended actions.

The reported grades suggest a watershed that needs improvement; there is room for optimism; continue to look for opportunities.
